Clarifications:

1. Question: We went by the apartment property to confirm areas marked for replacement. We came across several areas that were not marked and want to confirm if these need to be addressed as well or only the ones marked? RESPONSE: Please refer to the demolition schedule regarding parapets and other non-structural furred out elements. Those areas not visibly marked for repair with visible damage are likely designated for demolition. In the event that areas were inadvertently marked for repair, please refer to the demolition schedule. Also, in the event that areas designated for repair were missed, an additional square foot cost for stucco repair line item will be added to the Bid Form as "Unit Price E: Square Foot price to repair additional Stucco".
